The successful applicant shall assist with the long-range vehicle and equipment maintenance plan and in the development of a long-range replacement for all vehicles & equipment.

Candidates must hold up-to-date certificates/licenses in 310 S Automotive Service Technician, 310 T Truck and Coach Technician and Heavy-Duty Equipment Mechanic 421 A. Must have sound knowledge of welding and fabrication procedures garnered through a minimum of two (2) years applicable experience. Knowledge/certification in diesel and natural gas fuel systems is required; Completion of grade 12 plus post-secondary education in auto and equipment mechanics at a trade school and five (5) years of progressive experience as a Heavy Equipment Mechanic. In addition, you must have the ability to lift heavy objects (50 lbs) and be physically fit and capable of standing, climbing, walking on uneven surfaces, stooping, crouching and crawling for extended time periods.

The successful candidate must be able to provide a satisfactory Criminal Reference Check to the Township and must hold and maintain a valid class DZ license with a satisfactory driving record.
